Re: Greenfield Wastewater Utility - Sewer Use Ordinance Update

Mayor and Board Members,

The section in chapter 51 of our City code that defines our Sewer Use Ordinance (SUO) will need to be updated with the completion of our new WWTP and the issuance of a new NPDES permit for the facility. The SUO defines many things, but mainly covers what can be discharged to the City sewer system based on what our WWTP is capable of treating and what is prohibited. The industrial users within the City are currently permitted through IDEM, but ultimately are required to follow the restrictions set forth in our ordinance.

I requested a proposal from Commonwealth Engineers, Inc. to update our SUO and to also review the other sections of chapter 51 and update those as needed. Commonwealth submitted the attached Task Order # 2024-01 to complete this work. This update will be a combined effort between the City and Commonwealth and final direction will be determined by the City attorney in order to ensure that the update is consistent with the other chapters of the City code and is detailed in item 1.E. of their proposal. The total proposed estimated hourly, not to exceed cost for this work is \$25,000.00.

At this time, I am requesting that the approve Task Order #2024-01 for the estimated hourly, not to exceed cost of \$25,000.00. A copy of the proposal has been included for your review. Please let me know if there are any questions or if any other information is needed at this time.

In accordance with Paragraph 1.01 of the Agreement Between Owner and Engineer for Professional Services – Task Order Edition, dated August 13, 2019 ("Agreement"), Owner and Engineer agree as follows:

## 1. Background Data

E. Specific Project (description): This project will include the review and update the City's existing Sewer Use Ordinance (SUO) and Enforcement Response Plan (ERP) in accordance with the Indiana Department of Environmental Management (IDEM) and United States Environmental Protection Agency (USEPA) Non-Delegated Industrial Pretreatment requirements as identified in the City's NPDES Permit. A review and update of the City's numeric local limits will also be conducted in accordance with USEPA Region 5 requirements. Additionally, the remaining portions of the City's Chapter 51 Sewers will also be reviewed and updated consistent with other wastewater utilities in the State of Indiana with final direction from the Owner.

For lump sum items, Engineer may alter the distribution of compensation between individual phases (line items) to be consistent with services actually rendered, but shall not exceed the total lump sum compensation amount unless approved in writing by the Owner.

employees through the E-Verify program. The Engineer is not required to verify the work eligibility status of all its newly hired employees through the E-Verify program if the E-Verify program no longer exists.

The Engineer hereby certifies to the Owner that the Engineer does not knowingly employ an unauthorized alien. The Engineer further affirms that, prior to entering into its Agreement with the Owner, the Engineer has enrolled in and agrees to verify the work eligibility status of all its newly hired employees through the E-Verify program.

The Engineer shall provide to Owner a sworn affidavit on an annual basis or as requested by the Owner.

C. Pursuant to Executive Order 13846, the Engineer hereby certifies to Owner that Engineer is not engaged in Investment Activities in Iran."

In order to arrive at the total billing rate, the above direct payroll rates shall be multiplied by factors of 46.4654% and 96.4286% to account for payroll and general overhead costs respectively. In addition, a 15% profit level is then added to arrive at total labor costs. This is a total multiplier factor of 3.3086 times direct payroll rates.

### **Reimbursable Expenses**

- 1. Travel: Starts at the office and shall be at the then approved rate by the U.S. Internal Revenue Service, plus 15% profit.
- 2. Subsistence and Lodging: Actual Cost, plus 15% profit.
- 3. Express Charges and Postage, other than first class mail: Actual Cost, plus 15% profit.
- 4. Paper Prints: \$0.75 per square foot, plus 15% profit.
- 5. Special Tests and Services of Special Consultants (not used without specific written consent of Owner): Actual Costs, plus 15% profit.

It is agreed that the Owner will make payment of each invoice presented by Commonwealth within thirty (30) days from the date of the invoice. Payments received after this time shall be subject to an interest charge of 1% per month.
