Mayor and Board Members,

I am requesting the Board's permission to attend an American Water Works Association (AWWA) seminar on PFAS: Navigating Legal, Financial and Technological Challenges in Chicago, Illinois on 02-03 November 2023. This seminar will include roundtables with the top industry experts and the Governmental Affairs Director for the AWWA, and will focus on the upcoming regulatory requirements that all Public Water Systems will have to meet to mitigate these emerging contaminates.

As the Board is aware there are new changes proposed for the National Safe Drinking Water Act that will include standards for treatment of PFAS or what is called "forever chemicals". These chemicals are complex and extremely challenging to deal with and I feel that this roundtable opportunity will enable me to have critical guidance on the best way to lead our utility in the onset of this new set of challenges that will affect every public water system in the country.

The training itself is \$395 plus \$219 hotel accommodations. I am requesting to fly to this event using the most economical flight possible to get there and back safely and efficiently. The cost for the flight is approximately \$178. The only the other expenses would meals which will be paid for with the per diem rate of \$45 per day. Total trip cost is estimated to be \$792.00 which we have funds available for this seminar. I have included the travel itinerary and seminar schedule for your review.
