## **Greenfield neighborhood nominated to National Register**

--- Experts to highlight nominated district

Indiana Landmarks will unveil its nomination of the Greenfield Residential District to the National Register of Historic Places as a meeting on Tuesday, June 28 at 6:00 p.m. The Greater Greenfield Chamber of Commerce hosts the meeting at 1 Courthouse Plaza.

Candace Hudziak of H & H Associates was hired by Indiana Landmarks to prepare the nomination. At the meeting, she'll outline the district boundaries and review the 400 structures that contribute to the district, including six barns. She'll also highlight the most common architectural styles found in the Greenfield Residential District, which is bounded by Hendricks Street, Boyd Avenue, Wood and South Streets.

Rebecca Smith, Community Preservation Specialist at Indiana Landmarks, will be available to answer questions about the meaning of National Register status.

The National Register of Historic Places recognizes historically significant structures and sites. National Register status does <u>not</u> require property owners obtain approval of rehab or construction. It is primarily an honor conferred on buildings or districts that retain original historic architecture. Listing in the National Register of Historic Places also allows homeowners and owners of commercial property to apply for rehabilitation tax credits.

To help fund the cost of the nomination, Indiana Landmarks received a Historic Preservation Fund grant administered by the Indiana Department of Natural Resources, Division of Historic Preservation and Archaeology.
