Re: Maxim Automation – Lift Station Telemetry Replacements

Mayor and Board Members,

We currently have 6 lift stations that routinely lose communications with the main radio at the WWTP. The current radios are no longer available and repairs to this system is becoming more difficult. I requested that Maxim Automation provide a proposal to replace the radios in each of these lift stations with cellular modems and program them to communicate with our SCADA system at the WWTP. We have already had to change 2 of our lift stations to these radios and they have been working great. The lift stations that we will be updating are: Mooney's, Waterview, Fleming, Liberty Shores, Westside, and Prairie Meadows. The cost for each lift station is \$4,200.00 and includes the equipment, installation, and necessary programming modifications.

At this time, I am requesting that the Board approve the proposal from Maxim Automation for the replacement of the lift station telemetry radios at 6 locations for a cost of \$4,200.00 per station and a grand total of \$25,200.00. A copy of the proposal has been included for your review and I have confirmed that this proposal is still valid even though it has been more than 60 days since it was received. Please let me know if there are any questions or if any other information is needed at this time.

- We will perform offsite testing and setup up of the modem(s)
- We will get each modem installed and setup the PLC and SCADA PC to properly work with new addressing in the PLC.
- We will configure the Lift Station to be on SCADA with alarming, trending, etc
- Manufacturer lead time is 7-9 working days to ship from purchase order
