Agreement to Oversize Sanitary Sewer

Dear Members,

The referenced developer has upsized sanitary sewer in the referenced subdivision to a size larger than the minimum 8-inch diameter mains to serve future developments on adjacent properties. As such, the Staff is supportive to pay for the increased cost of \$27,167.02.

Staff recommends a motion to execute an agreement with Greentree Development, LLC for oversizing sanitary sewers within the Evergreen subdivision in the amount of \$27,167.02.

If approved, a pay claim will be added to the next voucher list. The July 2024 balance in the Sewer Availability Fund (127.2) was \$1,289,137.

## **AGREEMENT**

THIS AGREEMENT is made and entered into this \_\_\_\_\_ day of September, 2024, between the City of Greenfield, Indiana, acting by and through its Board of Public Works and Safety ("City") and Greentree Development, LLC, an Indiana limited liability company ("Developer").

### RECITAL

WHEREAS, Developer has received approval for a subdivision of approximately 71.65 acres, more or less, east of Blue Road and north of CR 200 N in Greenfield, Indiana (the "Real Estate"), which real estate is described on Exhibit A, attached hereto and incorporated by reference herein; and

WHEREAS, Developer is desirous of developing a subdivision known as Evergreen Estates on the Real Estate to be served by City water, City sanitary sewer and City electric, with a storm system approved by the City (the "Utilities"); and

WHEREAS, Developer has constructed, or had constructed, within Sections 1 and 2 of Evergreen Estates certain improvements requested by the City, which improvements consist of the oversizing the sanitary main from 8" to 10" with Record Drawings completed by Stoeppelwerth and Associates, Inc., which are incorporated by reference herein; and

WHEREAS, City required Developer to oversize certain portions of sanitary Utilities to accommodate existing and future development in the area of the Real Estate; and

WHEREAS, City and Developer desire to reduce this agreement to writing.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS HEREIN, CITY AND DEVELOPER AGREE AS FOLLOWS:

1. Recital. The Recitals are incorporated by reference herein.

## 2. Sanitary


- a. Developer, in order to adequately serve Evergreen Estates Sections 1 and 2 with sanitary sewer and to make provisions for future development, Developer was required to oversize the sanitary main.
- b. Developer incurred expenses in the amount of \$27,167.02 as shown on Exhibit B, attached hereto and incorporated by reference herein for the oversizing of the sanitary main by the City.

c. In recognition of work performed and costs associated with work performed at the request of the City, Developer shall receive a credit of \$0.00 of the Sanitary Availability Fee owed to the City associated with Evergreen Estates and a cash reimbursement of \$27,167.02 which sum to the amount of \$27,167.02, coincident with the expenses incurred.



9, A POST TELEVISING YIDEO, PROVIDED ON A USB DAVE, MAIST BE SUPPLIED TO THE WASTEWATER UTILITY, BULLOWING THE YEW REYALLATION OF ALL SANTARY SEWERS IN CREENFIELD, THIS WILL IPICLIZE ALL MANUS AND FOOTAGES TO LATERALS AND MARHIOLES.

12. A 2" "S" SHALL BE STAMPED ON THE CURB AT EACH LATERAL AND MANHOLE LOCATION.
