### Scope of Work

#### Solution Summary

This quote is for 12 (9 production, 3 spares) Juniper Networks switches to replace the production switches for City of Greenfield.

The spares do not include the redundant power supplies nor the additional power cord.

It includes Qubit Networks Professional services in which Qubit engineers will label, configuration, deliver on-site and provide a knowledge transfer. A Qubit project manager will coordinate these activities with City of Greenfield.

The quantity and Juniper models are quantity 8 (7 production, 1 Spare) EX4400-24X with 24 ports, quantity 3 (2 production, 1 spare) EX3400-48T with 48 ports, and 1 EX3400-48P with 48 ports and POE.

The rack break-down of each is:

Left Rack: Qty 2 EX4400-24X and 1 EX3400-48P.

Middle Rack: Qty 1 EX4400-24X and Qty 1 EX3400-48T.

RIght Rack: Qty 4 EX4400-24X and Qty 1 EX3400-48T.

DACs are included for each

The support on each includes 5 years of Juniper Mist Wired Assurance and 24x7 Juniper Tech support access.
