Re: WWTP Improvements Project: Change Order #9

Mayor and Board Members,

The boundary of the closed City dump was updated by IDEM after the WWTP Improvements Project was bid and awarded. The change in the boundary removed some of the work area from it, but also added some additional area. Change Order #9 for the WWTP Improvements Project has been submitted by FA Wilhelm Construction for the work that was completed in the updated boundary. This change order is for an increase in the total contract price of \$30,364.00. This has been reviewed by Commonwealth Engineers, Inc. and has been recommended for approval.

At this time, I am requesting that the Board approve Change Order #9 for the WWTP Improvements Project for an increase in contract price of \$30,364.00. This change would bring the new contract price to \$71,714,223.00 and no change in contract time. A copy of the change order summary has been included for your review. And the complete document is available for review in the Clerk-Treasurer's office. This will also be submitted to the IFA/SRF for their review and approval.
