Members:

Please be informed that an error was made when calculating the bond amounts for Brunson's Landing Section 3.

The Subdivision Agreement has been revised to reflect a corrected total performance bond amount. The original calculation of \$689,479.12 has been reduced to \$689.137.32 as submitted herewith.

The bond calculator spread sheet for the performance bonds was submitted with an incorrect amount listed for the cost to install streetlights. At the last BOW meeting we believed the bond was issued in error when in actuality it was the spreadsheet that was wrong. The original Bond # DUA002799 is correct at \$33,422,40, as indicated on the attached Engineer's estimate

Staff recommends approval of the revised Subdivision Agreement.
