State of Indiana: County of Hancock:

THIS AGREEMENT made and entered into this 25th day of February 2025 by and between <u>Gradison Land Development</u> ("Subdivider"), and the City of Greenfield, herein represented by the Board of Public Works and Safety.

WITNESSETH:

WHEREAS, the Subdivider has subdivided lots in the <u>Brandywine Farms Section 1</u> Subdivision, and has received approval and acceptance from the Board of Public Works and Safety for subdivision improvements constructed herein; and

WHEREAS, under the provisions of the Subdivision Control Ordinance, the Subdivider is required to maintain certain improvements for a period of three (3) years:
