Mayor and Board Members,

As per our contract with Brenntag Mid-South INC., an email has been provided to the Water Utility that as of the date of the email notice as of 28 February 2025 Brenntag is locking in the current price per pound of Chlorine gas at \$1.19. As this is the best pricing available, I am advising that the Utility will continue to order from Brenntag Mid-South, INC. for 2nd Quarter ending 30 June 2025. Prior to the end of the 2nd quarter of 2025, we will request updated pricing for service from all distributors and make the selection for service for 3rd Quarter ending 30 September 2025. We will provide another award letter at the time of selection for the 2nd Quarter to ensure that all parties acknowledge any change that may be selected.
