State of Indiana: County of Hancock:

THIS AGREEMENT made and entered into this 13<sup>th</sup> day of May 2025 by and between Olthoff Homes ("Subdivider"), and the City of Greenfield, herein represented by the Board of Public Works and Safety.

## WITNESSETH:

WHEREAS, the Subdivider has subdivided lots in the <u>Evergreen Estates</u> <u>Section 2</u> Subdivision, and has received approval and acceptance from the Board of Public Works and Safety for subdivision improvements constructed herein; and

WHEREAS, under the provisions of the Subdivision Control Ordinance, the Subdivider is required to maintain certain improvements for a period of three (3) years:

NOW THEREFORE, it is hereby agreed by and between the Subdivider and the Board of Public Works and Safety that the Subdivider hereby agrees to keep all components of the following improvements in the <u>Evergreen Estates Section 2</u> Subdivision in good condition, and will make such repairs to any effect in materials or workmanship as may develop or be discovered when called upon to do so by the Board of Public Works and Safety

It is agreed that this Agreement shall be in full force and effect for a period of three (3) years from May 13, 2025.
