

ORDINANCE NO. 2024/39

AN ORDINANCE AMENDING TITLE V, CHAPTER 54, § 54.20 - § 54.33

WHEREAS, the Common Council of the City of Greenfield, Indiana has heretofore approved provisions regarding stormwater management pursuant to Ordinance No. 2006-13 and as amended by Ordinance No. 2019-25; and

WHEREAS, from time to time, state and federal authorities review the provisions of the stormwater management program revising the same and requiring local municipalities to come into compliance with the newly amended provisions; and

WHEREAS, the State of Indiana working through and with the Greenfield Stormwater Utility and its professional advisors, Wessler Engineering, have determined that the provisions of Title V, Chapter 54, § 54.20 – § 54.33 are in need of such revision to the extent that they should be deleted and replaced with the provisions of Exhibit A, attached hereto and incorporated by reference herein; and

WHEREAS, the Common Council of the City of Greenfield, Indiana believes that replacing Title V, Chapter 54, § 54.20 - § 54.33 with the provisions of Exhibit A, attached hereto and incorporated by reference herein, is in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

Title V, Chapter 54, § 54.20 - § 54.33 are hereby deleted and inserted in lieu thereof are the provisions as set forth on Exhibit A, attached hereto and incorporated by reference herein.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
