The ECA will follow the procedures outlined by the Indiana Utility Regulatory Commission (IURC) in Cause No. 36835-S3.

The ECA will benchmark from the IMPA Rates and Charges imbedded in the rates and charges established herein. Such IMPA rates and charges embedded in the base rates herein include: 2025 Demand Charges (Blended Rate) of \$22.238 per kW and 2025 Energy Charges of \$0.044190 per kWh.
