

ORDINANCE NO. 2018-11

**AN ORDINANCE REGULATING TRAFFIC AND PROVIDING
PENALTIES FOR VIOLATION THEREOF**

BE IT ORDAINED by the Common Council of the City of Greenfield, Indiana that:

SECTION I

Schedule I of Chapter 74 of the Code of Ordinances of the City of Greenfield is hereby amended to include the following changes:

A. All traffic traveling northbound on Shady Drive shall stop at its intersection with Summerwood Boulevard.

B. All traffic traveling southbound on Blossom Court shall stop at its intersection with Leisure Way.

C. All traffic traveling northbound on Haywood Drive shall stop at its intersection with Silver Spoon Drive.

D. All traffic traveling southbound on Bobtail Drive shall stop at its intersection with Silver Spoon Drive.

E. All traffic traveling eastbound and westbound on Silver Spoon Drive shall stop at its intersection with Montezuma Express Drive.

F. All traffic traveling northbound and southbound on Montezuma Express Drive shall stop at its intersection with Silver Spoon Drive.

G. All traffic traveling southbound on Springdale Lane shall stop at its intersection with Meridian Springs Lane.

H. All traffic traveling southbound on Fresno Court shall stop at its intersection with Meridian Springs Lane.

I. All traffic traveling northbound and southbound on Van Buren Street shall stop at its intersection with Meridian Springs Lane.

SECTION II

Any person violating Section I of this Ordinance shall be subject to the penalties prescribed in Section 70.99 of the Code of Ordinances of the City of Greenfield.

SECTION III

The Street Department, in conjunction with the Greenfield Traffic Safety Committee, shall erect the necessary traffic control signs to carry out the terms and provisions of this Ordinance.

SECTION IV

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
