

**ORDINANCE 2019 – 13**

**AN ORDINANCE VACATING CERTAIN EASEMENTS**

**WHEREAS**, the Common Council of the City of Greenfield, Indiana, has received a Petition from the Greenfield Board of Public Works and Safety to vacate certain easements pursuant to I.C. § 36-7-3-12; and

**WHEREAS**, notice of such hearing to be had upon said Petition was given as prescribed by law, including publication in the Greenfield Daily Reporter, as well as by certified mail to all abutting and adjoining property owners; and

**WHEREAS**, the public hearing thereon was properly held and all interested persons were given the opportunity to participate.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:**

**SECTION I**

The following described easements are hereby vacated:
