REPLACEMENT FUND

Notice is hereby given to the taxpayers of Greenfield, Hancock County, Indiana, that the Common Council of the City of Greenfield, Indiana, will consider at 10 S. State St., Greenfield, Indiana 46140, at 7:00 p.m. on the 25 th day of May, 2022 an ordinance for the reestablishment of the Greenfield Fire Protection Territory Cumulative Fire Equipment Replacement Fund under the provisions of Indiana Code 36-8-14-4 and 36-8-19-8.5 for the following purposes: for all uses as set out in I.C. 36-8-19-8.5. The tax will be levied on all taxable real and personal property within the taxing district and will not exceed \$0.0333 per \$100.00 of assessed valuation.

The proposed fund will be levied beginning with taxes due for 2022 and payable in 2023. Taxpayers appearing at such hearing shall have the right to be heard thereon. The proposed tax rate for the Greenfield Fire Protection Territory Cumulative Fire Equipment Replacement Fund is subject to certification by the Department of Local Government Finance.

Within 30 days after the date of the adoption of the cumulative fund by the Common Council, City of Greenfield, Indiana will publish a Notice of Adoption. Upon publication of the Notice of Adoption, 25 or more taxpayers in the taxing district may file a petition with the County Auditor no later noon 30 days after the publication of the Notice of Adoption setting forth their objections to the proposed fund.
