Dear Members,

On October 22, 2019 we entered into a professional services agreement with Lochmueller Group for the design of the Riley Literary Trail. At the time, we assumed that the project would go to bid in October 2022 with the bulk of the design work completed by summer of 2022. The project has been out for bid twice so far through INDOT's system since there is federal money involved. The first round we had no bidders and the second time we only had one bid and it was 16% over the engineer's estimate; INDOT automatically rejects bids more than 15% of engineer's estimate per state statute. The project is set for a 3<sup>rd</sup> round bid in February 2024.

Due to these scheduling issues, minor design revisions, additional INDOT submittals, and ongoing/fluid utility coordination with Duke and the Riley Substation lines, we have incurred additional design costs that Lochmueller should be compensated for. Lochmueller has submitted amendment #1 with the additional work explained.

I would like to ask for approval of the professional services amendment #1 with Lochmueller Group in the amount of \$67,400.00 for a total not to exceed \$468,300.00.

#### **AMENDMENT #1**

WHEREAS, such changes are directly related to the designated project as described in the original AGREEMENT as Engineering Services related to **Riley Literary Trail** (Project); and,

WHEREAS, ENGINEER is willing to perform said services.

NOW THEREFORE, for and in consideration of the above representation, OWNER and ENGINEER agree that the AGREEMENT should be amended as follows:

- 1. "Attachment A" is incorporated to this Amendment for additional scope of work definition and fee justification.
- 2. ENGINEER's Compensation as called for in ARTICLE 8 of the original AGREEMENT shall be increased as follows:

Original + Amend. # = Total \$400,900.00 + \$67,400.00 = \$468,300.00

- 4. This AMENDMENT shall become effective on the latest date of execution by a required party.

All other terms and conditions of the AGREEMENT shall remain in full force and effect.

6. The AGREEMENT, as amended, shall expire <u>December 31, 2025</u>.
