## Exhibit A

The following services will be provided by Tri State Forestry Services Inc. to Greenfield Power and light regarding the emergency on call tree service contract.

- Individual tree removal within the City Right of way, disposing of all tree debris off site.
- Right of way clearing for new construction or utility relocating, disposing of all tree debris off site.
- Stump grinding.
- Forestry mowing.
- Right of way trimming/pruning for equipment clearance.
- Emergency response within 24 hours of initial notification Monday through Friday.
- Emergency response within 48 hours of initial notification on Saturday, Sunday and or Holidays.
- Emergency response service calls will be charged as follows.
  2-hour minimum for any emergency call.
  4-hours and over, 8-hour minimum charge.
  8-hours and over charged applicable rates per unit pricing.
- Storm damage cleanup within right of way, disposing of all debris off site.
- TSFS will provide the equipment and staffing necessary to complete project scopes. If rental equipment is required, all rental rates will be included in the invoicing and billed in accordance with standard unit pricing.

## The following conditions apply to this exhibit.

1. Any right of entry permission will be acquired by Greenfield Power & Light prior to work being completed.

- 2. All encroachment permitting will be handled by Greenfield Power & Light.
- 3. Project Scope of work will be provided by plan set, google images, or by onsite walk through.
- 4. Non-grindable debris to be left on site (rocks, fence, metal, bricks, small roots, etc.)
- 5. Utility location by TSF. Any utility daylighting or potholing to be completed by others.
- 6. Staging area and access, protective fencing, clearing limit staking, creek crossings as
- required, maintenance of traffic (including flaggers), and erosion control by others.

7. Any marketable timber will be obtained and become property of Tri-State Forestry Services, Inc.

- 8. Mobilization will be priced per unit pricing for all equipment required.
- 9. Small roots and spoil dirt to be left onsite.
- 10. No retainage, net 30 days.

11. Exhibit A is for tree removal as described. No tree inspection or arboricultural consulting is provided or implied. Structural integrity of trees remaining has not been inspected nor is guaranteed.
