Pursuant to the Advertisement for Bids, sealed bids for the above referenced project were received by the City of Greenfield's Board of Public Works on September 12, 2023 at 9:30am and then publicly opened and read aloud. We have reviewed all the Bids received for the Work and have enclosed a copy of the prepared Bid Tabulation for your information and consideration.

Two (2) sealed bids were received. The low bid was submitted by Phoenix Fabricators and Erectors, LLC of Avon, Indiana in the amount of \$8,950,000. The second low bid was submitted by Landmark Structures I, LP of Fort Worth, Texas in the amount of \$9,774,000. Donohue's opinion of probable construction cost for the Project was \$12,430,000. The low bid was approximately \$3,480,000 (28%) less than the opinion of the probable construction cost. Please refer to the enclosed Bid Tabulation for information on the Bidders and the bid amounts.

It is our opinion that the low bidder, Phoenix Fabricators and Erectors, LLC, submitted a responsive bid and is qualified and capable of performing the Work as specified. It is therefore recommended that the City of Greenfield's Board of Public Works award a construction contract to Phoenix Fabricators and Erectors, LLC, in the amount of \$8,950,000, and with the condition of the City's closing of the State Revolving Fund Loan.
