## ORDINANCE NO. 2024/15

#### **ORDINANCE TO AMEND ORDINANCE NO. 2024/06 AND TO TRANSFER FUNDS**

**WHEREAS,** the Common Council of the City of Greenfield, Indiana has heretofore adopted Ordinance No. 2024/06 regarding, in part, connection fees for the Greenfield Municipal Electric, Wastewater, and Water Utilities; and

**WHEREAS,** it has been determined that the fund number referenced in Section IX referenced as #6109 should be referenced as #6112; and

**WHEREAS,** now that a designated Water Connection Fee Fund has been established by ordinance, upon advice provided by the Utility Billing Coordinator, a transfer of funds from the Water Operating Fund #6101, into the Water Connection Fee Fund #6112, is required to adequately account for and utilize connection fees for the Greenfield Municipal Water Utility; and

**WHEREAS,** the Common Council of the City of Greenfield, Indiana, believes that the amendment to Ordinance No. 2024/06 and the transfer of monies within certain funds of the Greenfield Municipal Water Utility is in the best interest of the management of said utility.

**THEREFORE, BE IT ORDAINED** by the Common Council of the City of Greenfield, Indiana that:

### **SECTION I**

Section VIII of Ordinance No. 2024/06 shall be amended by changing the referenced fund number of #6109 to fund number #6112.

### SECTION II

For the purposes of depositing connection fees received in 2024 into the newly created Connection Fee Fund, the following transfer is hereby authorized to be made:
