

## **ORDINANCE NO. 2024/38**

### **ORDINANCE AMENDING TITLE III, CHAPTER 30 OF THE CODE OF ORDINANCES OF GREENFIELD, INDIANA AMENDING § 30.34 AND WITH THE ADDITION OF § 30.54**

**WHEREAS**, the Common Council of the City of Greenfield, Indiana has heretofore created the PACE Nonreverting Fund #2428 into which funds received as a result of participation of the Greenfield Police Department were to be deposited and out of which certain expenditures were authorized; and

**WHEREAS**, as determined by a recent audit, payment from Fund #2428 may not be made to compensate officers involved in the program for hours of overtime worked; and

**WHEREAS**, at the suggestion of the Auditors and the Clerk-Treasurer, the creation of a new Nonreverting Fund designated as the Justice Department Overtime Nonreverting Fund designated as Fund #2430 is required to be created in order to make earned overtime payments to applicable officers; and

**WHEREAS**, at the suggestion of the Clerk-Treasurer, Title III, Chapter 30, § 30.34 shall be amended to be entitled Justice Department Nonreverting Fund with the name change of the fund being made throughout the entire section; and

**WHEREAS**, the Common Council of the City of Greenfield, Indiana, believes the creation of the Justice Department Overtime Nonreverting Fund as recommended by the Auditors and the Clerk-Treasurer, as well as renaming the PACE Nonreverting Fund to be known as the Justice Department Nonreverting Fund is in the best interest of the citizens of Greenfield, Indiana and the efficient management of the monies received by and through the Justice Department Fund.

**THEREFORE, BE IT ORDAINED** by the Common Council of the City of Greenfield, Indiana that:

#### **SECTION I**

Title III, Chapter 30, § 30.34 shall be renamed as the Justice Department Nonreverting Fund which name change shall be carried out through all subsections of said provision.

#### **SECTION II**

Title III, Chapter 30 shall be amended by the addition of § 30.54 entitled Justice Department Overtime Nonreverting Fund and commonly referred to as Fund #2430 to be worded as follows:

§ 30.54 Justice Department Overtime Nonreverting Fund. There is hereby established a special Nonreverting Fund known as the Justice Department Overtime Nonreverting Fund referenced as Fund #2430. Initial contributions to said fund shall be made from the Local Option Income Tax Public Safety Fund #2240 in the amount of \$10,000.00. Thereafter the sole source of monetary contributions shall be overtime payments received from the Department of Justice. Said funds may only be expended in order to make earned overtime payments to applicable officers.

#### **SECTION III**

The fund previously denominated as the PACE Nonreverting Fund #2428 shall be renamed the Justice Department Nonreverting Fund #2428.

#### **SECTION IV**

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
