ORDINANCE NO. 2024/

AN ORDINANCE AMENDING TITLE III, CHAPTER 32

WHEREAS, under Title III, Chapter 32, various provisions are set forth regarding the procedures utilized by the Common Council of the City of Greenfield, Indiana to conduct business as the Legislative Branch of the City of Greenfield, Indiana; and

WHEREAS, the Common Council of the City of Greenfield, Indiana believes that certain amendments to said Chapter are required to further set forth procedures to be used by the Common Council of the City of Greenfield, Indiana in conducting its statutorily authorized business and that said amendments are in the best interest of the orderly conduction of business before the Common Council of the City of Greenfield, Indiana.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Greenfield, Indiana that:

SECTION I

Title III, Chapter 32, § 32.08(B) shall be deleted and in lieu thereof shall be inserted the following:

(B) All ordinances and resolutions shall be read by title only three (3) times before being passed and no ordinance shall pass on the same day which it is introduced unless it is in compliance with the provisions of I.C. 36-4-6-13.

SECTION II

There shall be added to Title III, Chapter 32, a new provision denominated as § 32.11 Petition Or Comments Of Citizens to read as follows:

§ 32.11 Petition Or Comments Of Citizens

Any citizen wishing to present a petition or make a comment during the course of a meeting of the Common Council of the City of Greenfield, Indiana shall stand, request recognition and once recognized, and approach the podium, be sworn in by the City Attorney, state their name, spell their last name, and give their address for the record, then present their petition or comment. Presentation of petitions or comments shall not exceed three (3) minutes in length unless, by a motion made, seconded, and duly passed by a majority of the Common Council of the City of Greenfield, Indiana to extend said time for a specified duration.

SECTION III

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
