Notice is hereby given that City of Greenfield, Indiana, Economic Development Commission will conduct a public hearing on June 9, 2025, at 3:00 p.m., local time, at the Richard J. Pasco Council Chambers, Room 127, located in the Keith McClamon Government Center, 10 South State Street, Greenfield, Indiana 46140, concerning a proposed form of Conditional Project Expenditure Agreement (the "Agreement"), which Agreement is a proposed type of financing to assist projects to be developed by TRG Development, LLC ("TRG"). Pursuant to the Agreement, the City of Greenfield, Indiana (the "City"), through its Redevelopment Commission (the "Redevelopment Commission"), will utilize tax increment revenues generated by new projects constructed by TRG in or serving or physically connected to certain redevelopment and economic development areas of the City (the "TIF") to assist in financing such projects.

The Agreement will not be an indebtedness or general obligation of the City and will not be payable in any manner by the taxing power of the City. The Agreement will provide that any financing assistance will be payable solely from the TIF, as pledged by the Redevelopment Commission.

At the time and place fixed for the public hearing, all taxpayers, residents or interested persons will be given an opportunity to express their views for or against the proposed financing in writing or in
